- Email address

When you visit our website we may collect:

- IP address

- Browser type and version
- Device information
- Website usage information
- Cookie preferences
- Pages visited

3. How We Use Your Information

We process personal data for the following purposes:

Event Communications

To:

- Provide event information
- Send ticket updates
- Respond to enquiries
- Manage registrations

Newsletter Communications

Where you have opted in, we may send:

- Event announcements
- Speaker announcements
- Ticket information
- Community news
- TEDx Coolhaven Women updates

You may unsubscribe at any time.

Website Improvement

To:

- Analyse website performance
- Improve user experience
- Monitor website security

4. Legal Basis for Processing

Under GDPR we process personal data based on:

Consent

For:

- Newsletter subscriptions
- Marketing communications
- Non-essential cookies

Legitimate Interest

For:

- Responding to enquiries
- Managing event operations
- Improving website performance

Contractual Necessity

For:

- Processing ticket registrations
- Delivering event-related services

5. Ticketing and Third-Party Services

We use trusted third-party providers to support our operations.

These may include:

- Eventbrite (event registration and ticketing)
- Mailchimp or equivalent email marketing provider
- WordPress website services
- Google Analytics
- Embedded social media content

These providers process data according to their own privacy policies.

We encourage you to review their policies before submitting information.

6. Event Photography and Video Recording

TEDx Coolhaven Women events may be photographed and filmed.

By attending an event, you acknowledge that photographs, audio recordings and video footage may be captured for:

- Event documentation
- Marketing purposes
- Social media content
- Future TEDx Coolhaven Women promotions
- TED and TEDx publication processes

Where practical, attendees may contact us regarding concerns about identifiable imagery.

7. International Transfers

Some service providers may process information outside the European Economic Area (EEA).

Where this occurs, we ensure appropriate safeguards are in place, including Standard Contractual Clauses or equivalent GDPR-compliant mechanisms.

8. Data Retention

We retain personal information only for as long as necessary to fulfil the purposes outlined in this policy.

Newsletter subscription data is retained until you unsubscribe.

Event-related information may be retained for operational, legal and reporting purposes.

9. Your GDPR Rights

You have the right to:

- Access your personal data
- Correct inaccurate information
- Request deletion of your data
- Restrict processing
- Object to processing
- Withdraw consent at any time
- Request data portability
- Lodge a complaint with a supervisory authority

For residents of the Netherlands, complaints may be submitted to the Dutch Data Protection Authority (Autoriteit Persoonsgegevens).
